10. THE BOARD

12. HERIDITARY TRUSTEES.

d) If activities of a hereditary trustee including the trustees mentioned in clause 11 (a) are not conducive to the well being of the trust he/she can be removed from the board of trustees/member of the trust only by three fourth majority of the hereditary members of the board at a given point of time give consent to that removal. Proper explanation should be called for and placed before the board for consideration before taking any action against that member. There is no appeal against the removal of the member.

13. **LIFE TRUSTEES:-**

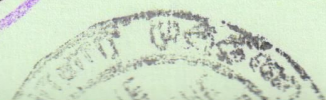
a) A person can be included as life member of the Board of Life Trustee with the consent of the two-third majority of the total hereditary members of the trust. For the purpose of this clause, the hereditary member mean the total numbers of hereditary members of the roll at that point of time.

b) The term of office of a life member is his life time.

c) If the activities of the life member are not conducive to the well being of the trust, he can be removed from the board of trustees before his life time with the consent of the two-third majority of the total hereditary members of the board.

For the purpose of this clause also the hereditary members mean the total number of hereditary members of the roll at that point of time. Before removing him proper explanation should be called for from the member and it should be placed before the board for consideration. There is no appeal against removal of the member.

14. NOMINATED TRUSTEES:-

- a) The managing trustee with the consent of the simple majority of the members of Board who are on the rolls at that point of time can nominate members as nominated members of the trust or nominated trustees.
- b) Term of nominated trustee will be two years.
- c) If the activities of the nominated member are not conducive to the wellbeing of the trust, the Board of trustees has got authority to remove him from the board without assigning any reason. To this effect a resolution should be passed with simple majority of the members of the present and the voting. There is no appeal against the removal of that member.

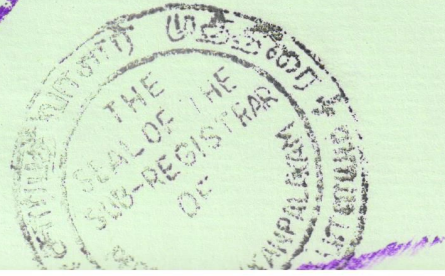
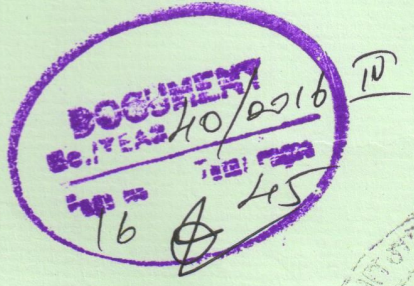

- 2) Life Trustees are also eligible for the post of managing trustee.
- 3) The managing trustee can open Bank account in the name of the trust and other institutions under the management of the trust in any of the nationalized banks and scheduled banks who will have the power on behalf of the trust and other institutions, to sign cheques, make payments, draw amounts and he has to operate jointly with the treasurer.
- 4) Whenever the managing trustee is on leave for less than 15 days the vice chairman of the trust will look after the functions of the managing trustee and during the period he exercise all the powers of the managing trustee. The managing trustee can delegate all his powers or a portion of it to any one or more of the hereditary members for specific period which is longer than 15 days and he can resume his powers at any time he wants whenever he wants to delegate his financial power (ie. Power for signing of cheques on behalf of the trust) to any one of the hereditary trustees, he must place the matter before the board and get it passed with simple majority of the members present and voting No power of the managing trustee can be delegated to the persons other that the hereditary members.

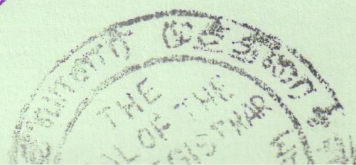
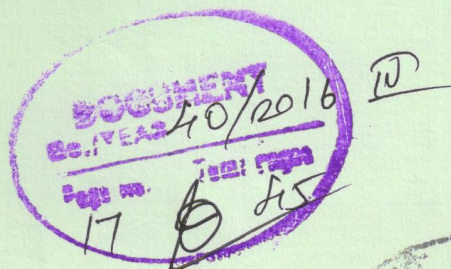

2) The persons so selected can continue in their post for one term (two years) and if re-elected he can continue for another term of two years. No person will be allowed to continue in their post for more than two terms continuously, but he can be elected again for the same post after a break of one term or two years.

3) Residual period which is less than one full year will not-be considered as one term.

POWERS OF THE TRUSTEES:-

- 18. The trustees shall have all powers necessary or incidental for effectively carrying out the objects of the trust.
- 19. Subject to the general provisions of the trust and without prejudice to the general and specified powers conferred upon the trustees by the other provisions contained in these presents the trustees shall have the following powers also.
 - i) To apply the trust moneys and properties for fulfilling one or some of the objects of the Trust in preference to the other objects.

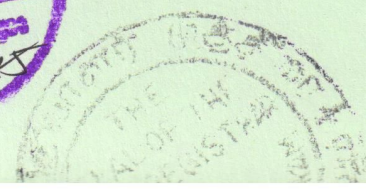
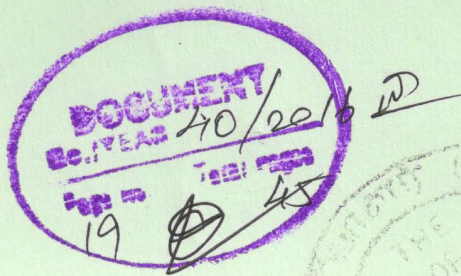

- ii) To decide the nature objects and functions of the institutions to be established by the Trust and to decide whether and if so which existing institutions may be taken over by the trust or to which financial aid may be given to achieve the objects of the trust.
- iii) In case it is decided to render financial or other aid to any person or institutions, to decide what terms and conditions should be complied with by such person or institutions, consistent with the objects of the Trust.
- iv) To determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by the Trust.
- v) To expand the funds of the trust in such manner as they shall consider most beneficial for the purpose of the Trust.
- vi) To acquire any property in exchange for some other property or partly for such exchange and partly for other considerations and to sell, demise, lease, give out on lease and/ or license, given in exchange, transfer, surrender, dispose of, take or give for hire, pledge, hypothecate or mortgage the property movable or immovable for the time being belonging to the Trust in such manner and on such terms as the Trustees may deem fit.
- vii) To enter into any contract on behalf of the Trust.

viii) To borrow or raise money for the purpose of the Trust at such rates of interest and upon such terms as may be agreed to and to draw, make, accept, discount, execute and issue cheques, promissory notes, and other negotiable or transferable instruments.

ix) To make and from time to time to repeal, add or alter regulation:-

- a) as to the management of the Trust and affairs thereof.
- b) as to the duties and remuneration of any officers on services of the trust.
- c) as to the conduct of any of the matters or things with in the powers or under the control of the Trustees provided that the same shall not be inconsistent with the provisions in these presents and repugnant to the provisions of Section 2(15), 11, 12, 13 and 80(G) of the income – tax Act, 1961 and any amendment made in the provision of the said Act from time to time.

x) To institute, conduct, defend, legal proceeding by or against the Trust and its trustees and to settle out of court, compromise or compound all suits, actions and other proceeding and all settle and approve all accounts without being answerable for any loss occasioned thereby.
